

### KANSIDARIN

Dat dih Priambl ah dih Political Kanstitusan ah 1991, kansiiv dih valiu ah dih founding principal ah dih republik dih laif kooexistan, dih work, dih justis, dih igualiti, dih nalige, dih libarty, ah dih piis inah wua juridik, demokratik, ah participativ friem wuork.

Dih Artikl tah dih Politikal Kanstitushan ah 1991 rikognais ah protek dih etnik a kultural diversity a dih nieshan kanstituit ah rector principl ah dih supiins adaring wi garantii dih fundamental raits.

Adishianali truu Laa 70 ah 1993 dih kolombian goument develop dih transitory artikl 55 ah dih political kanstitushan wue gih raits tu dih black komiunity we deh koming akiupain oh deh liv pah wies lan inah dih rural seekta next u di riva ah dih pacific laik ada sekta ah dih kontry wue geh simila kandishian dih rait tu koleectiv prapati ova sueh dih lan.

Wid dah finality dih Laa 70 ah 1993 rikognaisdih proteckshan dih kultural ah etnik diversiti a dih rait tu ikualitii ah aal dih koltia wih mek dih kolombian nashionaliti, dih rispek ah integrality ah dignity dih kultural laif ah dih komiunitis ah ihm organisheshan wihtout ditrimiend ah deh autonomi inah dih disishon we afek dem, ah inah aal dih nieshan wil inah ikual futing wid konformiti ah dih proteckshan ah dih invaiorment attending dih riliehanship establish bai dih black komiuniti wid nieshan. In vortia ah dih principle ah ikualiti dih magishment lais dih fuashmen a segregieshan wie dih Piepl fram dih afrokolombian koming deh afront dih govament hafi giv demn wua spieshal proteshian.

Fah dish rekgnishan ah obligieshan kim wid so muor, dih obligsion a dih atonomi, dih integrity, dih dignity, koltio ah dih black komiuniti ah also dih rait tuh kansalt dih adopshan ah eny disishan wi wil susceptibl ah afeck demh, establish bai dih kanstitushional laas ah dih kanvenshional 168 ah dih ILO (Internashinal Lieba Organaizieshan), aproov bai internal legislieshan as Laa 21 ah 1991.

Bai nashional ah internashional jusrisprudincy jai laa rekognais dih anproporshional impak inh kuantitativ ah kualitatives terms ah dih displiesment ah kanfaiment ah dih Komiunitis ah dih protekshan ah deh individual a kalettiv raits.

Inah dih disaining mekinop ah wua magl ah holistic ah transishional jostis dih nashional govament kansida gud fih dih black komiunity in gineral Afrokolombians, Raizales, ah di Palenkeros, nat only wid dih objetiv fih fulfill dih raits ah viktims fih (tel dem dih truut) deh nuo dih truut dih justis, dih riprieshan a fih g idem garantii dat ih no guain hapn agen, uonly adishinaly, loking fih ridius suoshal disikual wie deh inah dih kolombian sosaty ah dih viktims inah dih war kanflik, fih set up dih transishan pruoses ah nashional agriiment (kancilaizieshan) ovasalid bies ah ekuity ah soshial ikuality. Bai dih 10 ah juun 2011 dih laa fih dih integrieshion of viktims ah restitushan ah lan wie saing.

Bai wie mek soh steps fih gih dem ah tenshan, assistant ah integral reparieshan ah dih viktims wie inah dih integral gun kanflik, ah deh mek soh ada laa laik dih 1448 ah 2011.

Bay truuout dih Artikl 205 ah dih Laa 1448 ah 2011, dih Kolombian Kongres gih dih president extraardery ah prisais fakalty fih six (6) monts, fih mek ah lingual political friem fih wua poblik palicy fih atenshan, integral reparieshan ah lan restitushan be login ah dih black komiunity, Afrokolombian, Raizals, ah Palenkeros, akarding wid dih political kansttiushan, dih Internashional laas wie mek paat ah dih kansttiushional laas, dih jarisprudency, dih internashional principl ah dih truut dih justice, dih riparieshan ah fih mek sour ih no ripiit agen.

Akarding tuh dih 169 kanvenshan ah dih ILO (Internashinal Lieba Organaizieshan) ah dih kansttiushional jay laa (jurisprudency) in aal wie dih ting wie dish dikrii triit gah truu privious kansultashan, wid dih reprezentitiv ah dih Black Komiunity, Aforcolombians, Raizals ah Palenkeros.

# TAIKL I GINERAL DISPOSISHAN

## CHAPTA 1 *Objek ah kancep ah viktims*

**ARTIKL 1. OBJEK.** Ah dih present Dikrii gah dih objetiv fih establish dih kanstitiushional friem ah Laa ah dih instituisional atenshan, integral reparishan ah lan restitushan ah dih viktims raits bilagin tuh dih black komiunity, afrokolombians, raizals, ah palenkeros. Inh dans tuh Laa 70 ah 1993, gib dem administrietiv tuuls, justis mekanism, ah participieshan fih dih komiunity ah aal imh membas individualy wie shuda bii kansida fih gih dem bak deh raits akading tuh dih nashional kantitushan, dih internashional tuuls wie meet paat ah dih kanstitiushionaly friem wuork, dih laas, dih jaiya wuan, dih internashional principl ah dih truut, jastis, dih reparieshan ah dih gerantii fih in no ripiet agen, rispekin ah no dignifain dem ih kaltiu matirial existan, ancestral raits, ah deh oun koltio laik viktims.

Dih mejiament fih prevenshan, atenshan, asistant ah integral restitushan ah lan ah territory fih dih black komiunity, ash kolettiv sabyet fih dem memba kansidarin dem wua spieshal setop bil fih siepout wid dem akaa dih tuhdem etnik karakteristik a koltia deh gih dem dih rait ah deh kultiural aidentity, de autonomu dem oun rait dem matirial ikuality ah fisikal ah kultiural garantii fih dem sovaival.

**ARTIKL 2. AMBIT.** Dih present Dikrii reguliet dih aplikieshan kansarnin dih prevenshan, atenshan, asistant reparashan tuh dih viktims, restitushan ah lan ah territory in ah deh fundamentals a kolettiv raits ah dih black komiunity, afrokolombians, raizals ah palenkeros, akaading tuh ah establish ihna Laa 70 ah 1993.

Aal dih disposishon dih present Dikrii Laa, koming fram dih rekognishan ah dih sistematik viktimizer shan disproshional agents dih black komiunity afrokolombians pol ah deh raits laik individual viktims ah kolektiv violieshan ah internashional hiuman raits laas.

**ARTIKL 3. VIKTIMS.** Deh kansida viktims bai dih efek ah dihs dikrii aal dih black komiunity, afrokolombians, raizals, ah palenkeros ash kolettiv sujets ah dem memba individualy kansidering deh sofa wuan damige inah dih kconcept ah dihs Dikrii ah dih ack weh hapn fah dih 1° ah January ah 1985, ah kancekuence ah infrakshon ahvaiolashan agens dih Internashional Humanitieran Raits oh vayolashan, oh dih Internashional Hiuman Raits ah wie gah rielieshanship ah vinkuliet wid dih internal wuar, kanflik. Viktim kya bii di waif, oh dih porsun wie ih liv wid permant aal dih taim, demh fah dih siem sex ah famaly inah fos gried inah blod, fos inah civil paat dairektly da viktим tuh ifi deh kilim oh dem disa pier. If in noh gat demya pruuв dih wuan dehm wi inah sekant gried inah blod wih gah dih privilij.

Inh ada ah dih kolektiv riparieshan deh wi gat inh main aal dih famaly falaing dih ruul ah relativ ah komiunity afiliesshan. Inad dih siem wie deh kansida laik viktим dih person wie sofa wua damis wen ih tray fih gih help dih viktим wie inah dienja fih stap dish viktimieshan situieshan yuh get dih rit ah bii viktims frily ah deh individualais ih, deh kiapta dem oh praces dih wuan wie komit dish bad kandok ah dih famaly rielieshanship wie kya bii bituin dih wuan wie duh ih ah dih viktims, aal dih ligyal tings ah dihs Dikrii wih andastan in dih viktims ah dih sens ah eny referns ah dih viktims ah dih black komiunitys, raizals, ahn palekeros; wi bii andastan circuntanshal tuh dih viktims wie dihs Artikl refa tuh aal.

**PARAGRAF 1.** Dih memba dem ah dih organais gruup we deh out a dih lan deh nah guain kansida dem ash viktims ih uonly wie dihs kya bii hiden if dih picknini dem wie separiet fah did outalaa organais gruup we anda age.

Fih dih present dikrii go truu, dih hosbn or waif, dem we liit tugede oh dih relativ ah dih outa laa organais gruup kya bii kansida ahs dairek viktims, tih dih damit inah deh raits akading tuh dih present artikle, bot nat uhs indairek viktims fih dih damit wi deh sofa bay dih memba dem ah dih gruus.

**PARAGRAF 2.** Di piepl dem weh dah viktims fih aal dih tings weh hapm bifuor 1° ah January ah 1985, gah dih rait ah truh fijj deh tel dem dih truut, mejjament fih simbolik reparieshan ah fih deh gih dem garantii dat in noh guain hspn agen, akandi tuh dihs dikrii ahs paat oh dih huol sosial wit out did necesity fih bii ieh wuan.

## CHAPTA II *Detimshan*

**ARTIKL 4. KOMIUNITY AH PRAPA ATARITY:** Wih fih andastan dih kancep ah komiunity bai dih efek ah dis dikrii, dih black komiunity, dih afrokolombian, dih raizal, ah dih palenkeros piepl.

Dih andaslanding ah yuh oun atarity, daht dih administrietiv ah dih komiunity kounsil ah dih representativ ah dih komiunitis bifour instansis ah dih spieka wid dih govement.

**ARTIKL 5. TRANSISHIONAL JUSTIS WID ETNIK COLEKTIV AH CULTURAL FOKUS:** Fokusin wid etnik kolektiv ah kultural afiers wih fih andastan bai transishional justis wid etnik ah koleectiv a kultural afiens, aal dih laa ah mekanism pruoces ah extra asocictic wih dih intenshan ah dih sosaity fih gih garanti dat dih krain weh deh duh agiest dih komiunity ah imh menba dem, gih akount ah deh bigievia fih satisfai dih rait fih dem taak dih truut, fih justis ah fih intiigral repsneshan tuh dih viktims aka dih tuh artikl 3° ah dih present dikrii ah fih deh mek dih necesari chienf fah dih govement afis fih inh noh ripiet agen ah fih finisd ah aal dih iligyal gruup wid dih intenshan fih komtuh wua fainal ah nashional rekansilaishieshan fih pies aal dih taim wie wih kya sostien.

**ARTIKL 6. KOLEECTIV DAMIJ:** Dah wenh dih akshan vayoliet dih raist a dih bilanin a dih komiunity laik ah etnik kolektiv gruup akading tuh dih artikl 3° ah dihs dikrii. Wua kolektiv damij hapn wen dh hort wua big omount ah piepl sistematlyk deh individual raits dih membe ah komiunity. Dih nietio ah dih kolektiv damij yuh fainaut friliy difarent ah dih amaunt a piepl wie sofa dih damij. Aal du deh kye prisun wen deh gah wua sistematik vayiolashan ah deh individual raits ah dih memba ah dih komiunity ahs paat ah dih siem.

**ARTIKL 7. INDIVIDUAL DAMIJ AH ETNIK KOLKEKTIV EFEK:** Wua individual damij hapn wid etnik kolektiv efek wehn dih damij sofia bai dih viktim bilon tuh wua komiunity put inah risk dih suocial, kultural ah politikal aorganain stability, oh dih fisikal ah kultural laif fihstic inah komiunity fih dih guh ah dihs dikrii wehn wua individual damij hapn wid kolektiv wie, dihs go laik wuz kolektiv damij, ah dih komiunity wie ihm belong tuh, wi andastan laik wua etnik kolektiv viktim.

**ARTIKL 8. DAIMJ TUH DIH KULTURAL INTIGRITY:** Di komiunity sofia wua damij tuh deh kultural inigrity bikaas ah dih wuar kanflik wenh ihn

manifes wue laas oh wiiknis ah dih kapacity fih kantiniu reprodiuding kulturaly ah dih kanservashan ah transmishan fah dinarieshan tah ginarieshan deh kultural aidentity oh dih impasibility fih dvelop ah trnsmit deh aancestral nalige, wua etnik kolektiv damij haps wen ihn efek dih territorial, dih simbolik kultural ah patrimony ah dih komiunity tidem wie ah biin organais teh proudukshan ah deh oun reprensentieshan laik dih simbolik ah material element pah deh bilop deh kultural ah etnik aidentity.

**ARTIKL 9. TERRITORIAL AH INVAYOMENTAL DAMIJ:** Wua teritorial ah invayomental damij haps wen bai dih riizon ah dih wie ah dih viktims dem akaadm tuh artikl 3° a dihs dikrii, deh damij dih nashional ekosistem deh sostienabilty ah sostentability ah dih territorit bilong fuh dih komiunity.

Dih ripiering ah dih nashional ting araun wih ah dih adapshan ah mejiament fih dih protekshan hafi bii dih fos ting fih garantii dih siefgiad dih onbrokabl ritieshan bituin dih territory, nietio ah kultural aidentity.

**ARTIKL 10. DAMIJ BIKAAS AH RIECISIM AH RIESHALL DISKRIMINIESHAN.** Wih andastan yuh damij bai riescim ah rieshal diskriminies han bai dih efek ah dish Dikrii, wen eni kain ah vayiolens ah rieshall discriminies han wid okieshan oh bai efek ah dih wuar kanflik refa inh Artikl 3° ah dish Dikrii.

Deh prisium dat wuar ah dih efek aarm kanflik weh damij dihkomunity dah dih raipin ah risim ah rieshal diskriminieshan.

**ARTIKL 11. PIEPL WE FIH GAH SPESIAL PROTEKSHAN.** Di poepl bilaning tuh dih blak komiunity we sofa wua damij inah dih linit establish bai dish Dikrii deh ina cirkunstanshial, soshial tret, wiiknis ah without eny difens oh protekshan. Deh rikognanais insaid ah dih komiunity deh gat piepl akadn tuh deh sexual orientationshan, genda, ieg ah fisikal diskapacity hierung oh sikiatrik, hafi get speshial preferenshial trietmentl, weh deh hafi inh a kount deh speshal niid ah protekshan.

**ARTIKL 12. PROCIIDMENT AH RESTITIUSAN.** Ina did laa propuces we gah objektiv fih dih rikouaring ah deh plien exersais ah deh terotorial raits ah dih wiik komiunity inah dih kantex ah dih internal wuar kanflik.

**ARTIKL 13. JIUMANITIERIAN HELP.** Ih refa tuh dih mejiament adanpt fih help, fih protek ah fih aten dih necessity ah norishment, selfklining, manijiment yuh niid ah aal we, kiechin tings, medical ah emergency saiko logical, emergency transpotieshan ah atassitory lajin inah gud kandishan, dipendin ah dih niid we komop outa ah dih viktimalisin rong, ah dih

viktims refa inh Artikl 3° ah dih present Dikrii, fokus on bijah ah etnik deferens inah dih siem moument ah dih vayolieshan ah raits, oh inah doh moument wen dih atarity fain out we tekplies.

**ARTIKL 14. MEJAMENT FIH VIKTIMS ATENSHAN.** Wi fih andastan seh deh dih asistan we dih Artikl 3° refa tuh inah dih present Dikrii as viktims, aal dih integral mejament, prougrams, dih political riisource, ekonomik, social witin adars anda dih govement, inh-ada fih reestablish dih actual ah efektiov raits ah dih viktims refa dish present Dikrii, fih gih dem dih nesesary ting oh mour fih deh gat wua gud laif, ah gih dem dih garantii ah dih kandishan, fih deh goh bak tuh dih territory ah dem komiunity we deh bilan tuh, ah deh riseklment inh gud kandishan ah se kiourity, gud wil ah deh dignity.

**ARTIKL 15. ATENSHAN.** Andastan bai atenshan, dih akshan ah gih informieshan section missing

**ARTIKL 16. INTIGRAL REPARISHAN.** Dih integral reparishan refa tuh dih mejament ah dih restitushan ah dih terotory, indemnifikasishan, reabilitishan satisfakshan ah garantii ah noh repetishan ina nuh kain ah wie individual oh kolektiv.

Di simbolik riparieshan andestan ah aal dih mejament adap inh fieva a dih kolektiv piepl we dah viktims, we rikognais dih damij kaas ah fihmek shuor dih preservieshan ah dih historic memory, dih noh repetishan ah dih viktimaishin event, dih publik acceptstans ah we hapink dih rikuesment ah padn poblikly, ah dih restablishment ah dih dignity ah dih viktims.

### CHAPTA III *Principl*

**ARTIKL 18. FOKUS ON ETNIK DIFARENS.** Dih mejament fih atenshan, asistan, reparieshan, ah restitushan, establish inah dih presnt dikrii bies opon dih principl ah speshal ah diferent triiment ah dih komiunity gah

rait tuh ah dih memba individualy kansida. Dih norms, procidment ah mekanism disaing fih dih efek, hafi andastan inah birning ah kultiural ah dih kolektiv raitsah dih komiunity.

**ARTIKL 19. FISIKAL AH KULTURAL GARANTII FIH SORVAIVAL.** Aal dih mejament wi present inah dihs dikrii laa tuh gaid ah benefit dih fisikal ah kultiural sorvaival ah dih black komiunity.

**ARTIKL 20°. PRINCIPL FIH RISPEK DIH PRAPA RAIT AH DIH KOMIUNITIS:** Dih interpretations ah aplikieshan ah dih mejament inah dih present dikrii laa, hafi duh inah jarmony ihn rispek ah dih oun rait ah dih black komiunity, ihn rispek ah dih speshal laa fih dem, ahal dih ginaral disposishians ah fah dih repoblik.

**ARTIKL 21. PRINCIP INFIEVA AH DIH VIKTIMS:** Ihn kies ah existin kanflik ihn dihs dikrii laa ah dih laa 1448 ah 2011, dih aktual dikrii laa wih gah preferens, wid dih exceptshan ah dih sekant laa 1448 gah beta ting ah efectiv injoyment ah dih rait ah intnes ah dih komiunity.

**ARTIKL 22. PROGRESIVITY:** Dih goverment wigih garantii dih principl ah progres ihn aal gah rilieshan ah dih aplikieshan ah dih present dikrii ihn benefit ah dih black komiunity. Dihs sopoos dih compromais ah govament, fih staat garantii prouces ah efectiv injoyment ah hiuman kolektiv raits rispektin dih principl ah noh diskriminieshan ah ikuality. Dih obligieshan we adan fih rekognais sohm minimun kantex ah esenshial setisfakshan ah dem raits we dih govament hafi gih garantii tuh aal dih viktims ingrisim dehm litl bai litl.

**ARTIKL 23. ETINIK AH KULTIURAL RAIT FIH BII DIFARENT:** Di govament rikognais dih komiunity dah kanstitiut paat ah dih nieshan ah deh gat dih rait tuh kiip reprodius ah transmit dih tradisional avluu, praktis ah deh institiushan we sostien deh etnik ah kultiural aidentity. So dih kies, dih mekanism, mejament ah procidment kontemplet inah dihs dikrii, hatii garantii dis soraval ah dih kultatal aidentity ah dih komiunity.

**ARTIKL 24. DIGNITY:** Dih fioundieshan ah dih raits fih dih truut, fih ah integral reparieshan ah dih garantii ah noh repretishan, soh as dih asistant, mejament, ah integral atenshan tuh dih komiunity ah dip piepl, hafi duh ah rispeking deh laifi, ah autonomik integrity tuh deh repatieshan ah gud niem. Dihs jav dih objektiv ah dh administrieshan ah justis aktuashan inah dih friem wort ah dih kansikuens deh wih triit wid rispek ah wih participiet riily ah efectivly inad dih dieshan weh afek them.

**ARTIKL 25. AUTONOMY:** Inah dih implementieshan ah dihs dikrii, dih govement hafi rispek aal dih akshan, strategis ah liigyal inisiativ ah legitimient belonning tuh dih komiunity, exersaising politikal a kolektiv autonomy, tuards dih protekshan ah laif, libarry ah dih kultural integrity.

**ARTIKL 26. NOH DISKRIMINIESHAN:** Dih individual ah kolektiv riparieshan fih dih black komiunity, hafi gat akshan we rikognais ah abalis eny rieshal manifieshan, diskriminieshan, cenefubia ah soh ada kanex rieshal intolerans we exist aredy wid okieshan ah dih voyolieshan ah fundamentails kolektiv ah intigral raits we dihs dikrii refia tuh inah artikl 3°.

**ARTIKL 27. ETNOLINGUISTIC DAIVERSITY:** Dih viktims gah rait fih yuus deh oun languij inah aal dih prociidment ah deh atenshan, asistant, reparieshan ah restitushan, establish inah dih priesent dikrii. aswe deh hafi gih dem informieshan ah dih mekanism ah proviidment fih deh raits bii efectiv ah dih truut, dih justis ah dih riparieshan. Ihn dihs kies dih govement wih gah welnuon transtieta bai deh oun komiunity, bai dihs wie deh wih dih aplikieshan ah artikl 10 ah dih politikal kanstitiushan ah 1991.

**ARTIKL 28. GUDFIEST:** Wih premium dih gud fiet ah dih viktims individual ah kolektivly inah dihs dikrii. Deh kya gih kredit ah dih damij we deh sofa, truu eny kain midia, riedio, televishan, niuspiepa, liegyaly rikognais.

**ARTIKL 29. PUBLICITY:** Dih govement truu dih difarent entities we deh rispansability, kompeters ah fongshan ihn rilieshan tuh dih mejament kontempiet inah dihs dikrii hafi provaid mekanism ah publicity ah efektiv braadkiasting tuards giving gud informieshan tuh dih viktims kansarnig dih raits, mejament, siem ah dih administrietiv ah dih justis truu dihs we akas fih exersing deh raits.

**ARTIKL 30.
